➢ 2015 base year & 4.5%GDP, the total energy demand is 10,406.7MW in 20 years period; However, if 9.5% GDP, demand is 52,998GWH, i.e. 1270.3% increment (which is 22,129.9 MW in 20 years period). About 57% is in industry







- 11 -20 years: 50% exemption (hilly or himalaya Region)

- 6-8 years: 50% exemption on dividend


b. No VAT

- Transaction in foreign currency
- <u>Rebate on rent:</u> 50%, 40% & 25% in 1st, 2nd & 3rd yr, respect.








SEZ in 7 Province

Summary

- 1. High scope of investment on energy sector due to the big gap between demand and supply. The gap still aggravate when rapid industrialization begins in near future.
- Product specific (i.e. Assemble electrical) SEZ development and operation is possible jointly between Govt & Private sector or independently by private sector.
- 3. Solar panel assembly promotes clean energy which is useful for rapid power crisis management
